1. How will the LEA, to the greatest extent practicable, support prevention and mitigation policies in line with the most up-to-date guidance from the CDC for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning?

The Conestoga Valley School District developed and adhered to a robust reopening plan for the 2020/2021 school year which resulted in a full-day, five-days-a-week in-person option for our students. Over 80% of our students took advantage of the direct instruction in our school buildings, while the remaining 20% opted for an online option. The reason for the successful in-person option relied on the comprehensive actions listed (but not limited to) below:

- **Cleaning, sanitizing, disinfecting and ventilation**
- **Social distancing and wearing of masks**
- **Contact tracing and quarantining**
- **Monitoring of student and staff health**

The District remained consistent for the 2020/2021 school year in following the Board-approved Pennsylvania Department of Health (PDE) Health and Safety Plan for Reopening Schools. As state and federal guidelines changed, the District was flexible in its compliance. With the upcoming 2021/2022 school year, the District will review and discuss any recommendations from the CDC and PDE to determine if/how we can implement prevention and mitigation strategies, to greatest extent practical based on our community/District needs.

2. How will the LEA ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?

Since the District was "open" for the 2020/2021 school year, it will continue to provide all academic, social, emotional, mental health, physical health and food services to all students throughout the 2021/2022 school year, regardless of instructional mode chosen by the parents/students. We will continue to access and implement instructional strategies to close existing learning gaps brought on by the pandemic.

	<ul style="list-style-type: none"> Any individual on school property who develops COVID-19 symptoms, tests positive for COVID-19, or may be a probable COVID-19 will be directed to an isolation room/area until dismissal is possible. The school district will maintain adequate personal protective equipment for use when individuals become ill. If any individual exhibits symptoms while in a school building, a screening will be completed by the school nurse or designee.
<ul style="list-style-type: none"> Efforts to provide <u>vaccinations to school communities</u>; 	<ul style="list-style-type: none"> CVSD will continually promote local and regional options for vaccinations for families and students from our partners within the county and the local Intermediate Unit.
<ul style="list-style-type: none"> Appropriate accommodations for students with disabilities with respect to health and safety policies; and 	<ul style="list-style-type: none"> Individualized health and safety plans will be developed in collaboration with families, as needed, for students requiring additional accommodations regarding health and safety measures.


